This is with reference to the complain received from Dr. Subash Mohapatra, Executive Director, Global Human Rights Communications, Puri and news published in various local daily regarding killing of a new born baby from a girl student residing in a tribal hostel in Sundergarh.

The Commission has registered the above-cited matter and has desired to known the fact finding and action taken in this matter from your end within ten working days of receipt of this letter.

Further, the commission desires that, you need to take following steps to protect the rights of the child;

1. Extend appropriate medical care to the girl child and ensure that, she continue her education
2. Investigate the case and file FIR against the culprit and take immediate action
3. Ensure safety and security of all children residing in the hostel

This may be treated as extremely urgent.

We, Global Human Rights Communications, are writing to seek immediate and your personal intervention into the above subject line matter.

We are shocked to learn that a newly born infant from a ^{girl} ~~child~~ student in a tribal hostel in Sundargarh District was killed and buried by the public authority. The victim child is denied medical service and the authorities suppressed the facts to higher authorities and shield all the information. The attached news clipping is self-explanatory.

We request you to kindly intervene the matter by taking following measures:

- We request you to kindly intervene the matter by taking following measures:-
- Direct the State Government of Odisha to investigate the matter by an independent authority and report OSCPCR within a week;
 - Direct the State Government of Odisha to suspend the school and hostel authorities to prevent further malpractice during the investigation;
 - Direct the State Government of Odisha to bring culprits into court of justice;
 - Direct the State Government of Odisha to provide interim relief of RS 10 lakh to the victim mother
 - Direct the State Government of Odisha to provide security and ensure life and liberty of the student inmates in the state run hostels; and
 - Take any other measures that OSCPCR deems fit.
